It was reported vide complaint R.No.146/SS/Proc. dated 30.05.2014 by Fozia Amin Patigarae, a student of M.D. Physiology (IIInd Year) bearing En. No. DD-2385 that on 30.05.2014, aforementioned student misbehaved with her and also slapped.

It was further reported and alleged by her that she got married in January, 2014 and before that aforementioned student wanted to marry with her but on refusal, he at that time misbehaved but same was ignored thinking that matter will settle down in due course of time. But since her marriage Syed Tousif Ahmad Rizvi was continuously harassing her and crossing all limits of decency he slapped her on 30.05.2014 and also threatened her of dire consequences. One member inquiry was constituted to inquire into the incident for fixing responsibility. The inquiry member in her report has held Syed Tousif Ahmad Rizvi guilty of the charges.

Another complaint R.No. 2993/Proc. dated 17.05.2014 was lodged by Dr. Zulqarnain Masoodi, SR-III bearing En. No.BB-8577 that on 16.05.2014 aforementioned student sent unwelcomed messages to him on whatsapp and continuously followed him thereafter. When he approached aforementioned student to know why he was following him and messaging, aforementioned student instead of giving satisfactory explanation started laughing ridiculously. It was also complained by Dr. Zulqarnain that after few minutes Syed Tousif A. Rizvi, the aforementioned student barged into the JDO Office and started physically assaulting him without any cause or provocation consequently he sustained injury on his head.

It was reported by Dr. Zulqarnain that aforementioned student is a psychiatric patient and has history of violent and abnormal behavior. The abnormality in the behavior of aforementioned student was fortified in the inquiry report dated 20.05.2014 conducted by the Security Officer, Proctor's Office.

In view of the above facts, it was *prima-facie* made out that aforementioned student committed acts of indiscipline and misconduct as provided under Part-II, Rule-4 (iii) (iv) (vi) (vii) (xii) & (xiii) of AMU Students Conduct and Discipline Rules, 1985.

The aforementioned student was suspended from the rolls of the University vide Office Memo No 1935/Proc. dated 31.05.2014. The Charge Sheet was also issued to him vide LD.No. 2773/Proc. dated 14.08. 2014. The reply of the charge sheet was received in this office vide R.No. 4794/Proc. dated 19.08.2014. Hence the matter was listed for hearing. A notice was sent to the aforementioned student vide D.No.2783Proc. dated 14.08.2014 to present himself before the Discipline Committee on its schedule date and time for hearing and he accordingly appeared before the scheduled Discipline Committee.

In compliance of the principles of natural justice the articles of the charges were read over to him and he was required to explain his position. Explaining his position, Syed Tousif Ahmad Rizvi submitted that it was an emotional outburst but later on realised it was blunder on his part and therefore is now extremely remorseful for hurting the sentiments of a girl student and causing disrespect to her. He also agreed to apologize and the same was submitted in writing showing full regret for hurting the complainant. The copy of the apology has been sent to the complainant through the Dean, Faculty of Medicine.

In view of the above facts and circumstances the charges framed against aforementioned student were established under Part-II, Rule-4 (iii), (iv), (vi), (vii) (xxii) & (xxiii) of AMU Students' Conduct and Discipline Rules, 1985. But in view of the categorical apology submitted by Syed Tousif Ahmad Rizvi and his professional career, the Discipline Committee took the extremely lenient view and recommended the revocation of his suspension.

The Vice-Chancellor, therefore, on the basis of the recommendations of the Discipline Committee held on 21.08.2014 (Thursday) at 03:30 pm in the Pro-Vice-Chancellor Office has passed the following orders:

- (a) That Office Memo LD. No. 1935/Proc. dated 31.05.2014 placing Syed Tousif Ahmad Rizvi under suspension is revoked with immediate effect.
- (b) That Syed Tousif Ahmad Rizvi is required to furnish an undertaking in writing on Non Judicial stamp paper within a week from the service of the date of notice to maintain good behavior and not to repeat the same in future failing which *suo-moto* action will follow against him.

The aforementioned student has right to appeal before the Executive Council (referred hereinafter as EC) under Section 36 (B) of Aligarh Muslim University (Amendment) Act, 1981, if he is aggrieved from the aforementioned decisions within three months from the date of the service of this Office Memo.
