

The aforementioned, Adeel Ahmad was debarred from future admission vide Office Memo No. 2644/Proc. dated 23.07.2013 for next three academic sessions commencing from 2013-2014 onwards on the grounds stated therein. The case of aforementioned, Adeel Ahmad was placed before the Vice-Chancellor alongwith the case of Danish Ali for granting pardon.

It may be stated that as per record of this Office Adeel Ahmad, after being subjected to the disciplinary action has never been found indulging in any act of indiscipline or misconduct in the campus nor there is any adverse report/complaint of any authority of the University and/or student of the University against him. Therefore, it seems he has realized his culpability and wants to pursue his academic career.

In view of the above facts and circumstances, the Vice-Chancellor has passed the following orders:

1. That the ban imposed vide Office Memo No. 2644/Proc. dated 23.07.2013 on Adeel Ahmad is lifted and he is allowed to seek admission /continuation in any course/class as per rules of the University.
2. That he will furnish an undertaking in writing on a non-judicial stamp paper for keeping good behaviour in future while staying in the University as a student further ensuring that he would not indulge in any act of indiscipline or misconduct on and off the campus.
3. That Adeel Ahmad will complete as far as possible his course/class within specified academic duration.
4. That the concern department will maintain constant strict vigil over Adeel Ahmad after being enrolled in the class/course he is applicant.
