It has been reported and alleged vide complaint R.No.4829/Proc. dated 20.08.2014 and R.No.4878/Proc. dated 23.08.2014 by Azhar Amani Vazir, a student of BSW (F) bearing En. No.GA-9534 of S.S. Hall (North) that on 20.08.2014 at about 12:00 Noon, he was taking tea at the Library Canteen. The aforementioned student alongwith Mohd. Faizan and some other outsiders suddenly appeared thereon and attacked on him hurling abuses. It has further been complained by Azhar Amani Vazir that while he was badly beaten by one of the assailant Faizan setting a country made pistol (Katta) on his chest and pressed the trigger but luckily fire missed and he managed to run away by pushing away him but Faizan again fired at him while he was running away.

It has further been complained by Azhar Amani Vazir that aforementioned student and his friends are notorious ruffians and they have been continuously threatening him of dire consequence if he did not leave Aligarh.

In view of the above facts and circumstances it is *prima facie* established that aforementioned student has committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (iv), (vii) & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

On the basis of above misconduct and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University till the final decision of the competent authority. The University Campus and its maintained institutions are also placed out of bound for Abdul Manam.
