It has been reported and alleged vide complaint R.No.226/SS/Proc. & R.No. 5209/Proc. dated 01.09.2014 by Vaibhav Varshney, Class: MBBS-2009 Batch bearing En. No. GC-1113, Hadi Hasan Hall that on 31.08.2014 at the time of dinner, the aforementioned students attacked him in the dining hall on account of which he sustained injuries on his head and other parts of the body and therefore was admitted in the J.N. Medical College hospital for treatment.

Taking the serious note of the complaint under reference an inquiry committee was constituted to inquire into the facts and circumstances leading to assault on the complainant fixing the responsibility on each of the delinquent. According to report it is prima facie established that one of the aforementioned student, Shah Huzaifa Feroz attacked the complainant with desert spoon which led to the bleeding from his forehead and rest joined him in the scuffle. It is also evident from the report that complainant was chased by the aforementioned students up to main gate of Hadi Hasan Hall and was beaten by them thereupon.

In view of the above facts, it is *prima-facie* made out that aforementioned students have committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (vii) & (xxiii) of AMU Students' Conduct and Discipline Rules, 1985.

On the basis of above misconduct and indiscipline *prima-facie* made out, the aforementioned students are hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry. The University Campus and its maintained institutions are also placed out of bound for them.
