It has been reported by the Provost, Aftab Hall vide complaint R. No. 540/SS/Proc. dated 31.05.2015 addressed to the SHO, Civil Lines, Aligarh that in the intervening night of 30/31.05.2015 at about 1:30 a.m., Vice-Chancellor alongwith the Registrar, DSW, Proctor, Magistrate, ADM (City), S.P. (City), C.O (City) and other police officials raided Annexe Morison Court, Aftab Hall. In the course of search of the rooms of the Annexe four 12 bore cartridges were recovered. It has also been reported that in the Annexe under reference, aforementioned student has been residing.

In view of the above facts and circumstances, it is *prima-facie* established that aforementioned student has committed acts of indiscipline and misconduct as provided under Part-II, Rule 4 (xiv), (xxiii) & (xxviii) of AMU Students' Conduct and Discipline Rules, 1985.

On the basis of above misconducts and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University till the final decision of the competent authority. The University Campus and its maintained institutions are also placed out of bound for him.
