It has been reported & alleged vide R. No. 77/PS/FE dated 28.07.2015 addressed to the Vice-Chancellor by Dean Faculty of Engineering & Technology, AMU, Aligarh that you being a student of B.Tech. (Mechanical, II Year) bearing Faculty No. 13MEB-268, En. No. GE-8080 appeared in the admission test of B.E. (Mechanical) 2015-16. It has also been brought to the notice of the undersigned that you in order to secure a seat adjacent to Syed Aatif Ahmad to assist him illegally & wrongfully during the course of entrance test mentioned in your application form information such as date of birth, mobile number, email address, Hall and address etc. identical to the information furnished by Syed Aatif Ahmad in his application form. It shows that whatever you did, was with the malafide intention to cause illegal & wrongful gain to your companion i.e. Syed Aatif Ahmad for reasons better known to you.

Taking cognizance of the complaint under reference, a show cause notice vide D. No. 2281/Proc. dated 04.08.2015 was served to you whereby you were required to submit your reply within three days from the receipt of the show cause notice. Your reply has been received on 12.08.2015 vide R. No. 4509/Proc. wherein you admitted the fact that you appeared in the entrance test of BE (Mechanical) 2015-16 & filled the application form with the information identical to the Syed Aatif Ahmad.

It is therefore established from the facts mentioned hereinabove that the alleged acts of you amount to misconduct & indiscipline as provided under Part-II Rule- 4 (x), (xi), (xxii), (xxiii) & (xxiv) of AMU Students' Conduct & Discipline Rules, 1985.

On the basis of above misconducts & indiscipline, you are hereby placed under suspension with immediate effect from the rolls of the University pending enquiry, in exercise of the powers delegated by the Vice-Chancellor to the undersigned. The University Campus & its maintained institutions are also placed out of bound for you.
