OFFICE MEMO

In terms of the Extract from the minutes of the ordinary meeting of the Executive Council dated 17.01.2015 and in the light of Office Memos No. Admin/LD/1097/T dated 29.04.2015 and Admin/LD/402/T dated 02.02.2016; the practice of appointing Assistant Professor out of the panel for temporary appointment recommended by General Selection Committee against the vacant post of Professor/Associate Professor/Assistant Professor initially for one year and extendable for a maximum of two years was in vogue.

2. The University Grants Commission, New Delhi in the meeting held on 02.09.2016 to finalize the Non-Plan Budget Estimate for 2016-17 and review of Plan Expenditure of XII Plan which was attended by the then Registrar, Finance Officer has made objection to the above appointment of teachers and emphasized that all such appointment be made on **Contractual Basis (Fixed Salary)** as per Clause 13 of the UGC Regulations, 2010.

3. Accordingly, the entire matter was submitted to the Vice Chancellor. The Vice Chancellor, on behalf of the Executive Council under Section 19 (3) of AMU Act, 1920 has ordered to substitute the Office Memos No. Admin/LD/1097/T dated 29.04.2015 and Admin/LD/402/T dated 02.02.2016 to the effect that all the appointments recommended by the General Selection Committee on panel for temporary appointment as Assistant Professor against the available vacant post of Professor/Associate Professor/Assistant Professor be treated as Assistant Professor on contractual basis for a period of one Academic Session on a fixed salary of Rs. 58, 144/- per month which will be reviewed as and when the gross salary of a regularly appointed teacher is revised. Such appointments would be initially for not more than one Academic Session and the performance of any such entrant should be reviewed for academic performance before re-appointing her/him on contract basis for another session as per UGC Regulations, 2010.

4. Those selected through Local Selection Committee on temporary assignment will be treated as Guest Teacher and will be entitled for remuneration as applicable for Guest Teachers.
