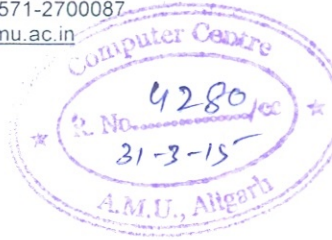

APPEAL

The Aligarh Muslim University Court under Item No.10 of its meeting held on 21.01.2007 & 25.03.2007 considered and accepted, in principle, the proposal for instituting "Sir Syed Ahmad Khan National & International Award" for the year 2008 and authorized the Vice-Chancellor to constitute a Committee to examine the feasibility for the same.

A committee was constituted and it was suggested that there should be Corpus Fund for the said purpose.

Under Item No.11 of the Executive Council held on 17.01.2008 the report submitted by Dr. Mahfooz Ahmed Committee regarding the modalities for raising the corpus for instituting the Sir Syed Ahmad Khan National & International Award was considered. After detailed deliberation the Executive Council resolved that:

1. The University shall establish only one award entitled 'Sir Syed Ahmad Khan International Prize'.
2. Establish a corpus amount of Rs. 2.5 Crores for sustaining the cost of award on a long term basis and approach the Ministry of Human Resource Development for getting the amount as one time assistance.
3. The University may issue an appeal to the University teachers / students / employees / old boys to make voluntary contribution to create this corpus.
4. The Vice-Chancellor has been authorized to form a National Level Committee of eminent personalities to determine the nature of the award and the rules regarding the same.
5. The Sir Syed Ahmad Khan International Prize may be given every year on Sir Syed Day. The first award was given on October 17, 2008 out of the fund available under the head "Founder's Day" (FAD CSG-35).

Conferment of the said award could not continue as no grant was received from Ministry of Human Resource Development / University Grants Commission. The establishment of a corpus fund of 2.5 Crores for sustaining the cost of award was not done.

In view of above and as resolved by the Executive Council in its meeting held on 17.01.2008 there is no other way except to request, you to kindly come forward to make Voluntary contributions to create this Corpus in the manner as decided by the Executive Council to recommence the "Sir Syed Ahmad Khan International Prize."

The University Teachers and employees are requested to submit their consent to the Deputy Finance Officer (Salary) for deducting the amount of contribution from salaries, all the alumni of the University are requested to send their contribution to the Finance Officer of the University, either through crossed Cheque or Demand Draft, enabling the University to continue the yearly award in the name of founder of the University
