It has been reported and alleged vide R.No.1813/Proc. dated 28.03.2017 by Mohd. Nadeem Ansari, Class: MSW (Final) bearing En. No. GD-9922 that aforementioned students misbehaved and used abusive language unnecessarily on 28.03.2017 with Mr. Mohd. Nadeem during the practice of riding session at Riding ground, while he opposed to do so, the aforementioned students became violent and tried to scuffle with him and created nuisance at the Riding ground. It has further been reported that aforementioned students also threatened him for dire consequences in future.

Taking the note of complaint, show cause notices were called to the aforementioned students vide LD.No.1042/Proc. & 1054/Proc. dated 29.03.2017 and required to submit their replies within 24 hrs. from the receipt of the show cause notices. The replies of the notices were received in the Office of the Proctor vide R.Nos.1876 & 1877/Proc. dated 30.03.2017 and found not satisfactory.

In view of the above facts and circumstances, it is *prima-facie* established that aforementioned students have committed act of indiscipline and misconduct as provided under Part-II, Rule-4 (i), (iii), (iv) & (xxiii) of AMU Students' Conduct & Discipline Rules, 1985.

Therefore, the aforementioned students are hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry.
