It has been reported and alleged vide complaint D.No.974/Proc. dated 23.03.2017 by Mohit Kumar, Class: B.Sc. (Final) bearing En. No. GI-3896, Pranveer Singh, Md. Danish, Jay Kumar Singh, Manzoor Ahmad and other classmate of Mohit Kumar that aforementioned students alongwith two outsiders brutally beaten to Mohit Kumar on 23.03.2017, while Pranveer Singh, Md. Danish, Jay Kumar Singh, Manzoor Ahmad tried to resolve the dispute, the aforementioned students also beaten to them. On 22.03.2017 aforementioned students used abusive language against Mohit Kumar and his companions & also threatened them physically assault with the help of outsiders. It has further been reported that aforementioned students pelted stones upon Mohit Kumar and his companions. Resultantly a stone hit Mohit Kumar, he injured and hospitalized. In this regard, an FIR has also been registered in the Civil Lines Dodhpur, Aligarh.

Taking cognizance of the complaint, Show Cause Notices were served to the aforementioned students whereby they were required to submit reply within 24 hours from the date of receipt of Show Cause Notices. The replies of the aforementioned students have been received in the Proctor's Office on 25.03.2017 and found not satisfactory.

In view of the above facts and circumstances, it is *prima-facie* established that aforementioned students have committed acts of indiscipline and misconduct as provided under Part-II, Rule-4 (iii), (iv), (vii), & (xxiii) of AMU Students' Conduct & Discipline Rules, 1985.

Therefore, the aforementioned students are hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry. The University campus and its maintained institutions are also placed out of bound for aforementioned students.
