

It has been reported and alleged vide complaint D.No.974/Proc. dated 23.03.2017 by Mohit Kumar, Class: B.Sc. (Final) bearing En. No. GI-3896, Pranveer Singh, Md. Danish, Jay Kumar Singh, Manzoor Ahmad and others classmate of Mohit Kumar that you alongwith Mohd. Shafaq, Class: B.Sc. (Physics) En.No. GI-4684, Abdullah Faraz Ahmad Class: B.Sc. En.No. GE-1657 and two others outsiders brutally beaten to Mohit Kumar on 23.03.2017, while Pranveer Singh, Md. Danish, Jay Kumar Singh, Manzoor Ahmad resolve the dispute, you alongwith your companions also beaten to them. Yesterday you were used abusive language to Mohit Kumar and his companions & also threatened to beat from the outsiders. It has further been reported that you alongwith Mohd. Shafaq, Abdullah Faraz Ahmad and two others outsiders pelted stones upon Mohit Kumar and his companions. Resultantly a stone hit Mohit Kumar, he injured and hospitalized. In this regard, an FIR has also been registered in the P.S, Civil Lines Dohpur, Aligarh.

In view of the above facts and circumstances, it is *prima-facie* established that aforementioned students have committed acts of indiscipline and misconduct as provided under Part-II, Rule-4 (iii), (iv), (vii), & (xxiii) of AMU Students' Conduct & Discipline Rules, 1985.

You are, hereby required to submit your explanation within 24 hrs. from the date of receipt of this notice, failing which it shall be presumed that you have nothing to say in your defence and *ex-parte* action will follow against you as per the rules of the University.
