Applications on prescribed form are invited for the appointment of Guest Teacher in the Department of Agricultural Economics & Business Management, Faculty of Agricultural Sciences for the Academic Session 2016-2017. The payment of fixed emoluments as per university rules. The appointment will be made on purely temporary basis liable to termination at any time without notice or assigning reason.

Qualifications:

- ix. Good Academic record as defined by the concerned University with atleast 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign University.
- x. Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, ICAR or similar test accredited by the UGC like SLET/SET.
- xi. Notwithstanding anything contained in sub-clause (i) and (ii) above candidates, who are or have been awarded a Ph.D Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulations, 2009 shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor of equivalent position in Universities/ Colleges/ Institution;
- xii. NET/SLET/SET shall also not be required for such Master Programmes in Disciplines for which NET/SLET/SET is not conducted.

Note:

- (vii) A relaxation of 5% may be provided at the graduate and Master's level for the Scheduled Caste/ Scheduled Tribe/ Differently-abled (Physically and visually differently-abled) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions. The eligibility of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.
- (viii) A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D Degree holder, who have obtained their Master's degree prior to 19 September, 1991.
- (ix) Candidates with MBA degree will be subject to regulation/ relaxations as prescribed by AICTE

Application duly filled should also be submitted in the office of the Chairperson. Last date for submitting application form is 2.3.2017. The interview will be held on 3.3.2017 at 10.00 a.m. in the office of the Dean, Faculty of Agricultural Sciences, AMU.
