

The aforementioned student was placed under suspension from the rolls of the University vide Office Memo LD.No.4048/Proc. dated 28.11.2016 pending enquiry charges mentioned therein.

Accordingly, Inquiry Committee consisting of two members namely Dr. Anwar Ahmad and Dr. Shafiullah was constituted by the undersigned to inquire into the facts alleged in the complaint made against the aforementioned student. During the course of inquiry, the complainant, Mr. Yasir Siddiqui, Class: Diploma Engineering, En. No. GI-2618 and aforementioned student have compromised with the involvement of AMU Students' Union Office Bearers. Thus, the aforementioned student moved an application to the Office of the undersigned vide R.No.463/Proc. dated 28.01.2016, thereby he has requested to revoke his suspension based on the said compromise in writing by the aggressive students.

On the basis of the above facts and future of the aforementioned student, the Vice-Chancellor has taken lenient view and keeping into consideration of his academic record, the suspension of Md. Nadeem Gauhar, the aforementioned student is hereby revoked subject to the fulfill of the following conditions.

1. That Md. Nadeem Guhar is fined Rs.2000/- (Two thousand only) and same may be deposited within in a week from the service of the notice in the Finance and Accounts Department, AMU under the head 'Fine' through the Challan form of SBI, AMU branch and submit a copy of the receipt of the fine in the Proctor's Office.
2. That aforementioned student is required to furnish an undertaking in writing on non judicial stamp paper within a week from the service of the notice to maintain good behavior and will not indulge in unlawful activities during the period of stay in the University. He is strictly warned to be more careful in future, failing which severe disciplinary action will be initiated against him.
