
OFFICE MEMO

It has been reported and seriously alleged vide complaint R.No. 8665/Proc. dated 18.12.2013 by Abdul Kader, En. No. GE-6265 a student of BALLB and resident member of Dr. B.R. Ambekar Hall that the aforementioned student alongwith a group of ruffians and hooligans comprising Tariq Azmi, Atiullah, Faraz alias Akbar and Muneer and others who were approximately 10-12 riding on the bikes reached at a Dhaba near Purani Chungi, where he was taking tea alongwith few friends. It has further been reported and alleged that aforementioned student alongwith his companions by reaching over there started opening indiscriminately fire on him and his friends sitting at Dhaba without any cause or provocation. Abdul Kader and his friends just to escape indiscriminate firing attempted to run away but allegedly the aforementioned student fired aiming at him. Consequently he sustained gun shot injury below the knee in his left leg and fell down but his friends somehow managed to escape the fire shots. Thereafter Abdul Kader in bleeding condition was taken to the J.N. Medical College hospital for immediate medical aid.

The aforementioned student was suspended in past from the rolls of the University but was given a chance to improve himself by withdrawing the charges but again in other case for his proved involvement he was made NRSC and was fined of Rs. 2000/- alongwith an undertaking to keep good behaviour. But in view of the above facts and circumstances he seems to be incorrigible and persistent threat to the law and order in the campus.

In view of the above, it is *prima-facie* made out that aforementioned student has committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (vii), (xiv), (xxii) & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

On the basis of above misconduct and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry. The University Campus and its maintained institutions are also placed out of bound for him.
