It was reported and alleged vide complaint D.No. 955/Proc. dated 08.03.2014 by Syed Hasan Mehndi, an Ex- Student that on 08.03.2014 at about 06:00 pm he alongwith his brother Mohd. Hasan were going along side the road of Azeem Apartment. It was further reported that while they were walking on the road suddenly six persons, including the aforementioned student, riding on two motor bikes came near them and opened fire with the intention to kill them. Consequently, Mohd. Hasan sustained gun shot in his arms. It was further reported by Syed Hasan Mehndi that at time of attack his brother Mohd. Hasan indentified one of the attackers and rest were identified by the complainant himself. It was also reported that after attacking them aforementioned student and his accomplices snatched away the purse and mobile of his brother Mohd. Hasan. In the said purse there were Rs. 2500/-. The purse of complainant was also snatched which contained Rs. 3700/-. It was further reported that after opening fire on the complainant and his brother, the aforementioned student and his accomplices threatened them of dire consequence if they did not leave Aligarh.

In view of the above facts, it was *prima-facie* made out that the aforementioned student committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (vii), (xiv) & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.


The aforementioned student therefore was suspended from the rolls of the University vide Office Memo No 983/Proc. dated 11.03.2014. The Charge Sheet was also issued to him vide LD.No.1135/Proc. dated 20.03.2014. The reply of the charge sheet was received in this office R.No. 1940/Proc. dated 25.03.2014 at 06:45 pm. Taking a note of the matter, an inquiry committee was constituted to get at the bottom of the truth. The inquiry accordingly was conducted. (Copy of report enclosed.). Hence the matter is listed for hearing. A notice D.No. 1238/Proc. dated 31.3.2014 was sent to Mohd. Faizan Ali Khan to present himself before the Discipline Committee on its schedule date, time and venue.

The aforementioned student accordingly appeared in person before the Discipline Committee on the scheduled dated and time. The Chairman of the Discipline Committee complying with the principle of natural justice read over the article of the charges and required the student under reference to explain his position.

Mohd. Faizan Khan while presenting his case submitted before the DC that on the alleged date and time of the incident he was in the Office of the Controller regarding the examination of a student who was run over by rashly driving car and same was found worthy of credit in tandem with a preliminary inquiry report. Hence the Committee unanimously arrived of the conclusion that aforementioned student was falsely implicated in the reported incident and therefore no misconduct and indiscipline was proved against him. Therefore, the Discipline Committee took the lenient view and recommended the revocation of his suspension.

The Vice-Chancellor, therefore, on the basis of the recommendations of the Discipline Committee held on 03.04.2014 (Thursday) at 05:30 pm. in the Pro-Vice-Chancellor Office has passed the following order:

That Office Memo LD.No.983/Proc. dated 11.03.2014 placing suspension of Mohd Faizan Ali Khan is revoked with immediate effect.
