It was reported and alleged vide complaint D.No.70/Proc.(SS) dated 18.03.2014 by Mohd. Waseem, bearing Enrolment No. GH5747, Class XI PCB that on 17.3.2014 at 11:00 pm while he was going to reading room, the aforementioned student alongwith his friends Aryan Khan (XII), Masoom Raza (XII), Nihal Ansari (XII) and others suddenly intercepted him and demanded ransom but on refusal by him aforementioned student alongwith others started assaulting Mohd Waseem with kicks, fist and rod and thereafter they fled away.

Another complaint D.No.103/Proc. (SS) dated 14.04.14 was lodged by Zaidul Islam Sherwani, Enrol.No. GH1526, Class XI-Arts against aforementioned student that on 14.04.14 he was in his room No. 42 (A Unit), Allama Iqbal Hall in the meantime Wafa Sarwar alongwith his friends Abdul Azeem Azmi, Musahid and some outsiders barged into his room and attacked him causing injury on his face.

In view of the above facts and circumstances it was *prima facie* established that aforementioned student committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (vii), (xiv) & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

The aforementioned student therefore was suspended from the rolls of the University vide Office Memo LD. No 1451/Proc. dated 16.04.2014. The Charge Sheet was served upon him vide LD.No. 2774/Proc. dated 14.08.2014. The reply of the charge sheet was received in this office R.No. 216/SS/Proc dated 18.08.2014. The reply being not satisfactory, the matter was listed before the Discipline Committee for appropriate recommendation after due hearing. The notice was sent to the aforementioned student vide D.No.2784/Proc. dated 14.08.2014 requiring thereby to present himself before the Discipline Committees held on 21.08.2014 but he did not turn up before the Discipline Committee. Therefore his case was deferred to next Discipline Committee which was later scheduled on 20.10.2014 at 4:00 pm. The aforementioned student however accordingly appeared before the Discipline Committee held on 20.10.2014 but due to absence of the complainant the matter was again deferred to the next Discipline Committee meeting. The Discipline Committee was again scheduled on 16.02.2015 at 3:30:00 pm in the Pro-Vice Chancellor's office for the consideration of the cases listed before it. The

complainant and complainee both appeared before the Discipline Committee to explain their respective positions.

The Chairman of the Committee read over the charges to Wafa Sarwar and gave full opportunity to defend the charges framed against him. It was brought to the notice of the Discipline Committee that Wafa Sarwar was made N.R.S.C. for misconducting with Haider Zia in the Allama Iqbal Hall. He also failed to convince the members of the Discipline Committee that he was innocent and will improve himself. The Discipline Committee therefore was of the view that the delinquent students is incorrigible. He has habitually indulged in the activities subversive to law and order in the campus.

Therefore, on the basis of the facts on record and attending circumstances it was proved that Wafa Sarwar was guilty of misconducts and indiscipline as provided under Part II, Rule 4 (iii), (vii), (xiv) & (xxiii) of AMU Students' Conduct and Discipline Rules, 1985.

The Vice-Chancellor, therefore on the basis of the recommendation of the Discipline Committee held on 16.02.2015 at 03:30 pm. in the Pro Vice-Chancellor Office passed the following order:

- (a) That aforementioned student is expelled from the rolls of the University for one academic session i.e. 2014-2015.

The aforementioned students has right to appeal before the Executive Council (referred hereinafter as EC) under Section 36 (B) of Aligarh Muslim University (Amendment) Act, 1981, if he is aggrieved from the aforementioned decision within three months from the date of the service of this Office Memo.


It has been reported and alleged vide complaint D.No.70/Proc.(SS) dated 18.03.2014 by Mohd. Waseem bearing Enrolment No. GH5747, Class XI PCB that on 17.3.2014 at 11:00 pm while he was going to reading room the aforementioned student alongwith his friends Aryan Khan (XII), Masoom Raza (XII), Nihal Ansari (XII) and others suddenly intercepted him and demanded ransom but on refusal by him they started assaulting him holding down with kicks, fist and rod and flaunting country made Pistol (Katta) they fled away extorting Rs. 800/- from him.

It has also been reported and complaint vide D.No. 103/Proc. (SS) dated 14.4.2014 by Zaidul Islam Sherwani, Enrol.No. GH1526, Class XI-Arts that on 14.4.2014 he was in his room No. 42 (A Unit), Allama Iqbal Hall in the meantime Wafa Sarwar the aforementioned student alongwith his friends Abdul Azeem Azmi, Musahid and some other outsiders barged into his room and attacked with the butt of the country made Pistol (Katta) consequently he sustained injury on his face.

It is also evident from the inquiry report conducted into the incident reported by Mohd.Waseem and the report of Provost Allama Iqbal Hall that aforementioned student is a habitual trouble maker.

In view of the above facts and circumstances it is prima facie established that aforementioned student has committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (vii), (xiv) & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

On the basis of above misconduct and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry. The University Campus and its maintained institutions are also placed out of bound for Wafa Sarwar.
