Md. Zeeshan Azam, bearing En. No. GD-9792 Class: B.A. (History) was suspended from the rolls of the University pending inquiry vide Office Memo No. 1087/Proc. dated 18.03.2014 on the basis of the complaint R.No. 1707/Proc. dated 15.03.2014 lodged in this Office by you.

A Discipline Committee Meeting was held on 10.06.2014 (Tuesday) at 12:00 Noon in the Office of the Pro Vice-Chancellor to consider grounds of suspension for making necessary recommendation to the Vice-Chancellor for his final decision. Md. Zeeshan Azam and you, both were required to appear before the Discipline Committee on its scheduled date and time to clarify their position.

You, Hilal Khan explaining sequence of event submitted before the Discipline Committee that Md. Zeeshan Azam was called on telephone by the person who was riding on the bike at the time of accident whereas Md. Zeeshan Azam contradicting this fact said that in fact he was riding on the bike at the time of alleged incident and was not called by anyone and thereby your oral submission did not match with your written complaint against Md. Zeeshan Azam. The Discipline Committee therefore, noting sharp contradiction in your statement considered it unworthy of credit and recommended to warn you not indulge in nefarious activities in future.

The Vice-Chancellor, therefore, on the basis of the recommendations of the Discipline Committee held on 10.06.2014 (Tuesday) at 12:00 Noon in the Pro-Vice-Chancellor Office has passed the following order:

- (a) That Hilal Khan, the complainant is warned to refrain from indulging in any undesirable or nefarious activities in future.
