

It has been reported and alleged vide complaint R.No.4907/Proc. dated 22.08.2014 by Sadiq Hussain, a student of B.A. (Sanskrit) bearing En. No. FB-8080, M.M. Hall that on 21.08.2014 at about 05:30 pm he was standing at entry gate of Proctor's Office alongwith his friends Mohd.Ahmad and Faizan for making complaint about a previous incident, in the meantime aforementioned student alongwith some outsiders riding on bikes came over there and started assaulting him with kicks and fist. He anyhow managed to escape by running away and while he was running away, the aforementioned student aiming at him opened fire with country made pistol (Katta) but luckily escaped. It has been mentioned in complaint that it was Shoeb who pursued him holding a pistol in his hand and was shouting you (Sadiq Hussain) cannot escape and will kill him.

In view of the above facts and circumstances it is prima facie established that aforementioned student has committed acts of indiscipline and misconducts under Part-II, Rule-4 (iii), (vii), (xiv) & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

On the basis of above misconducts and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University till the final decision of the competent authority. The University Campus and its maintained institutions are also placed out of bound for Azhar Amani Vazir.
