

It has been reported and alleged vide complaint D.No.2861/Proc. dated 21.08.2014 by Mohd. Khalid, a student of Diploma Engineering bearing En. As soon as aforementioned student and his friends saw him started abusing without any reason and when he (complained) protested over unprovoked abuses, one of the friends of aforementioned student, Azhar Amani Vazir slapped on his face and started beating him with kicks and fists. The aforementioned student and his friends are continuously threatening the complainant of dire consequences.

In view of the above facts and circumstances it is prima facie established that aforementioned student has committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (iv), (vii), & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

On the basis of above misconduct and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University till the final decision of the competent authority. The University Campus and its maintained institutions are also placed out of bound for the above-noted student.
