

It has further been reported and alleged by Azhar Amani Vazir that perceiving threat to the life, he attempted to escape by running away but aforementioned student alongwith his companions continued to chase but luckily he escaped from there. It has further been reported by Azhar Amani Vazir that aforementioned student is a notorious hooligan and is prone to sabotage peace and order in the campus.

In view of the above facts and circumstances it is prima facie established that aforementioned student has committed acts of indiscipline and misconducts under Part-II, Rule-4 (iii), (vii), & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

On the basis of above misconduct and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University till the final decision of the competent authority. The University Campus and its maintained institutions are also placed out of bound for Fahad Alam.
