It was reported by the Provost, S .S. Hall (South) vide complaint dated 26.12.2014 that the aforementioned student was in the possession of number of stolen items (inventory enclosed) in his room No. 49, S.S. Hall (South). Taking the note of the complaint, the Proctorial team reached on the spot and aforementioned student alongwith articles/items recovered from his possession was brought to the Proctor's Office. The Proctorial team after preliminary inquiry arrived at the conclusion that all the items recovered from the possession of the aforementioned student were stolen items.

Therefore, in view of the above stated facts, it is prima-facie established that aforementioned student committed the acts of indiscipline and misconduct as provided under Part-II, Rule-4 (xxii) (xxiii) & (xxviii) of AMU Students' Conduct and Discipline Rules, 1985.

The aforementioned student was therefore suspended from the rolls of the University vide Office Memo LD. No 4215/Proc. dated 27.12.2014. The University campus and its maintained institutions were also placed out of bound for him. The charges were specified in the Office Memo No. 4215/Proc dated 27.12.2014 and he was also required to give reply of the same within stipulated time. But reply of the charge sheet has not been given by the student.

The aforementioned student was required vide notice D.No.519/Proc. dated 13.02.2015 to be present before the Discipline Committee on its scheduled date and time for explaining his position he but did not appear before the Discipline Committee. The Proctor apprised the members of the Committee about the charges made out against the aforementioned student. The list of the stolen items recovered from his possession were also brought to the notice of the members of the Committee.

Therefore in view of the above facts, it was proved that aforementioned student committed acts of indiscipline and misconduct as provided under Part-II, Rule 4 (xxii) (xxiii) & (xxviii) of AMU Students' Conduct and Discipline Rules, 1985.

The Vice-Chancellor therefore, on the recommendation of the Discipline Committee held on 16.02.2015 at 03:30 pm, in the Pro Vice-Chancellor Office passed the following order:

- (a) That Shariful Islam is expelled from the rolls of the University for five academic sessions commencing from academic session 2014-2015 to 2018-2019.

The aforementioned student, has right to appeal before the Executive Council (referred hereinafter as EC) under Section 36 (B) of Aligarh Muslim University (Amendment) Act, 1981, if he is aggrieved from the aforementioned decision within three months from the date of the service of this Office Memo.
