It was reported and alleged vide complaint R. No. 274/SS/Proc. dated 31.10.2014 (at 2:00 a.m.) by Shahzeb Ahmad, Hony. Secretary AMUSU that at about 12:15 a.m. of the intervening night of 30/31.10.2014 while he was meeting with his friends and supporters at the Election Camp in S. S. Hall (North), afore-noted students alongwith Zafar, Shoaib, Ghaznabi and Azhar Amani Vazir etc. riding on bikes flaunting country made pistols (Katta) and swords barged into his Election Camp. According to the complaint Zafar and Shoaib taking the position opened fire with country made pistol (Katta) targeting the complainant Shahzeb Ahmad but luckily the fire missed and he narrowly escaped. It was also complained that perceiving the life in danger, the complainant somehow attempted to run away from the scene of occurrence but the assailants chased him up to outside of the S. S. Hall (North) continuously firing aiming at him. It was also reported that sound of fire arm terrified the general students of the hall and after few minutes a large number of the students came out from their respective rooms. Noticing the surging of the students towards the camp, the assailants escaped from the scene of occurrence in a Scorpio Car and Black Colour Bolero. According to the complaint Mohd. Faizan is the witness of the incident under reference.

In view of the above facts, it was *prima-facie* made out that aforementioned students committed acts of indiscipline and misconduct under Part-II, Rule-4 (iii), (vii), (xiv) and (xxiii) of AMU Students' Conduct and Discipline Rules, 1985.

The aforementioned students, therefore were suspended vide Office Memo LD.No. 3625/Proc. dated 31.10.2014 from the rolls of the University pending enquiry. The University Campus and its maintained institutions were placed out of bound for them. The charge sheets was served upon each student vide LD.Nos.4161 & 4162/Proc. dated 22.12.2014 respectively. The replies of the charge sheets were received in this Office. Notices were sent to the aforementioned students and the complainant vide D.Nos.281&281/Proc. dated 27.01.2015 and D.No.288/Proc. dated 27.01.2015 respectively to be present before the Discipline Committee on its scheduled date and time for explaining their position before the Discipline Committee held on 16.02.2015 (Monday) at 03:30 pm in the Pro-Vice-Chancellor office for hearing. They accordingly appeared before the Discipline Committee on its scheduled date and time but their cases were deferred to the next Discipline Committee meeting due to absence of the witness of the case and non availability of inquiry report. Therefore, again notices were sent to the aforementioned students vide D.Nos.873 and 874/Proc. dated 20.03.2015 respectively to re-appear before the Discipline Committee scheduled on 23.03.2015 at about 5:00 pm in the Pro-Vice-Chancellor's Office. The witness of the case was also again required to appear before the Discipline Committee on 23.03.2015.

Mohd. Moshin Iqbal and Mohd. Faraz accordingly appeared before the Discipline Committee but Mohd. Faizan, the witness again did not turn-up despite service of notice upon him. The complainant had appeared in person before the Discipline Committee held 16.02.2015 and in deposition partially substantiating his complaint further accused Mohd. Faraz for opening fire arms upon him and his supporters while he was meeting with the students in his camp in S. S. Hall (North) after declaration of student's union election result but partially contradicting his own complaint testified that he did not see Mohd. Mohsin Iqbal involved in the alleged violence rather he noticed him standing near the scene of occurrence as an onlooker. The inquiry report dated 26.02.2015 has also not indicted Mohd. Mohsin Iqbal for any act of indiscipline and misconduct but inquiry report has indicated Mohd. Faraz for his involvement in the incident dated 30/31.10.2014.

Therefore, in view of the above facts, deposition of the complainant and the inquiry report dated 26.02.2015 it was proved that Mohd. Mohsin Iqbal is not guilty of any misconduct and indiscipline but Mohd. Faraz has committed acts of indiscipline and misconduct as provided under Part-II, Rule-4 (iii), (vii), (xiv) and (xxiii) of AMU Students' Conduct and Discipline Rules, 1985 but the Discipline Committee took the lenient view in their case.

Therefore, on the recommendation of the Discipline Committee held on 23.03.2015 at 05:00 pm. in the Pro Vice-Chancellor Office, the Vice-Chancellor has passed the following orders.

- (a) That Office Memo LD.No.3625/Proc. dated 31.10.2014 placing Mohd. Mohin Iqbal and Mohd. Faraz under suspension is revoked with immediate effect.
- (b) That Mohd. Mohsin Iqbal is warned to be more careful in future and maintain good behaviour while staying in the University as a student. In case again he is found involved in any act of indiscipline and misconduct, he will be liable to severe punishment as per the rules of the University. He is also required to furnish in writing an undertaking to this effect in the Office of the Proctor within a week from the receipt of the notice.
- (c) That Mohd. Faraz is fined Rs. 2000/- (Rupees two thousand only) to be deposited in the head of fine through the challan in the Canara Bank, AMU Branch within a week from the receipt of the notice.
- (d) That Mohd. Faraz is strictly warned to be more careful and maintain good behaviour in future while staying in the University as student. In case he is found involved in any act of indiscipline and misconduct in future he will be liable to severe punishment as per the rules of the University. He is also required to furnish in writing an undertaking to this effect in the Office of the Proctor within a week from the receipt of the notice.
