It was reported and alleged vide complaint R.No.7626/Proc. dated 12.12.2014 by Shadan Afroz, a student of B.E. (Electrical) bearing En. No. GD-1181 of Ross Masood Hall that on 12.12.2014 at about 06:00 pm aforementioned students alongwith Adil, Deepanshu and approximately 30-35 unknown outsiders barged into Ross Masood Hall and attacked the complainant with country made pistol (Katta) and sharp edged weapon by breaking open his room. It was also reported that aforementioned students alongwith their group mates also assaulted Shaksham Mourya, a friend of the complainant and a former student of the University who had come to see the complainant in the Hall. Shaksham Mourya reportedly sustained injuries on his head, hands and other parts of the body due to assault. It was also alleged and reported that aforementioned students and their group mates after wounding the complainant and his friend Shaksham Mourya also looted Rs. 5000/- and the Laptop from his room. It was also reported by the complainant that with a view to create terror in the hall aforementioned students alongwith their group mates forced the gate keepers to close the gate at the gun point.

It was therefore established from the facts mentioned hereinabove that the alleged acts of the above mentioned student amounted to misconducts and indiscipline as provided under Part-II, Rule-4 (iii), (vii), (xiv) & (xxiii) of AMU Students Conduct and Discipline Rules, 1985.

The aforementioned students, therefore were suspended vide Office Memo No. LD. No. 4087/Proc. dated 13.12.2014 from the rolls of the University and the University Campus and its maintained institutions were also placed out of bound for the above-noted students. The charge sheets were sent vide LD. Nos. 4163 & 4164/Proc. dated 22.12.2014. The replies of the charge sheet were not given by the students under suspension. Notices were sent to students under suspension and the complainant vide D.Nos.284&285/Proc. dated 27.01.2015 and D.No.290/Proc. dated 27.01.2015 to be present before the Discipline Committee on its scheduled date and time for explaining their position before the Discipline Committee scheduled on 16.02.2015 (Monday) at 03:30 pm in the Pro Vice-Chancellor office for hearing. Sheeraz Ali Khan accordingly appeared before the Discipline Committee on its scheduled date.

and time but Mohd. Khalid and complainant did not turn-up, therefore case was deferred to the next Discipline Committee meeting. Therefore, notices were again sent to the aforementioned students and the Complainant vide D.Nos. 870,871 and 872/Proc. dated 20.03.2015 respectively to re-appear before the Discipline Committee on 23.03.2015 at about 5:00 pm in the Pro-Vice-Chancellor's Office.

Sheeraz Ali Khan accordingly again appeared before the scheduled Discipline Committee but Mohammad Khalid did not again appear before the Discipline Committee despite service of the notice upon him. The complainant Shadan Afroz again did not appear despite service of notice upon him. Sheeraz Ali Khan was examined by the Discipline Committee and he to certain extent convinced the Discipline Committee members that he was innocent. The members of the Discipline Committee therefore, in view of the facts on record and continuous defiant attitude of the complainant arrived on the conclusion that complaint under reference was concocted for implicating Sheeraz Ali Khan and Mohammad Khalid in a false case.

In view of the above facts and continuous none appearance of the complainant despite service of notice upon him, it was proved that charges framed against afore-noted students are not sustainable.

Hence, on the recommendation of the Discipline Committee held on 23.03.2015 at 05:00 pm. in the Pro Vice-Chancellor Office, the Vice-Chancellor has passed the following orders.

- (a) That Office Memo LD.No.4087/Proc. dated 13.12.2014 placing Sheeraz Ali Khan and Mohammad Khalid under suspension is revoked with immediate effect.
- (b) That Sheeraz Ali Khan and Mohammad Khalid are discharged from the charges levelled by Shadan Afroz against them vide his complaint No.7626/Proc. dated 12.12.2014 in the Proctor's Office.
