It has been reported and alleged vide complaint R. No. 1440/proc. dated 17.03.2015 by Mohd. Aslam, class B. Tech. bearing En. No. GD-9689, N. T. Hall, that on 16.03.2015 he had gone to Sulaiman Hall to study with his classmate. It has further been reported that after study he started playing cricket with some of the students of the Sulaiman Hall and while the game was going on you become aggressive and indulged in heated arguments with the Complainant. Thereafter you left the ground and came back after some time with some other boys and forced the complainant to come to his room. It has further been reported that on the refusal by the complainant you alongwith 10-15 students at about 9:30 pm came and beaten the complainant with hockey stick and rods. It has also been reported that you threatened also to shoot the complainant.

On the basis of the above stated facts and circumstances, it is established that you have committed acts of indiscipline and misconduct as provided under Part II, Rule-4 (iii), (iv), (vii), (xiv) & (xxiii) of AMU Students' Conduct and Discipline Rules, 1985.

In view of above facts and circumstances the following orders are passed.

1. That aforementioned student is fined Rs. 1,000/- (Rupees One Thousand only) to be deposited under the head 'Fine' in the Canara Bank, AMU, Branch through the challan form within 07 days from the receipt of this notice failing which *Suo Moto* action will follow against him and submit a copy of the cash receipt in the office of the undersigned.
2. That the aforementioned student is strictly warned to be more careful in future, failing which strict disciplinary action will follow against him.
