
It has been reported and alleged vide complaint R.No.2840/Proc. Dated 23.05.2015 addressed to the Proctor by Mr. Tausif Alam, former Vice-President, AMUSU that on 23.05.2015 at about 05:00 pm he received a call from Shahanshah Khan a student of Ph.D, department of law from the mobile set of Mahtab Alam Khan that he wants to see him and therefore asked his location. It has further been reported that when complainant Tausif Alam refused to meet him, the aforementioned students alongwith some outsiders after some time reached his room and entered therein holding fire arms, stick, rods etc. It has further been complained by Tausif Alam that aforementioned students alongwith their companions picked him at the point of fire arms and thereafter he was taken to M. M. Hall. Further taking him in M.M. Hall the aforementioned students alongwith other started beating him mercilessly with hockey stick and butt of Country made pistol. It has also been complained that Shahanshah Khan, aforementioned student opened fire at the complainant with Katta but unfortunately fire missed else he would have been killed. It has also been complained that due to beating the complainant started vomiting, and became unconscious. Therefore, he was immediately shifted to J.N. Medical College Hospital by the Proctorial team for the treatment. It has also been reported that aforementioned students alongwith their companions left no stone unturned to kill the complainant.
