It has been reported and alleged vide complaint R.No.549/Proc. dated 07.06.2015 addressed to the SHO, Civil Lines, Dadhpur, Aligarh through the Proctor, by Mohd. Sadiq S/o Dr. Mushtaq Ahmad, Class: B.E. (Civil) II<sup>nd</sup> year bearing En. No. GB-1267 resident of Dhorra Mafi, Aligarh that on 07.06.2015 he alongwith Aatif Afaq S/O, Afaq Ahmad, Class: B.E. II<sup>nd</sup> year En. No. GE-6210 resident of Ross Masood Hall. They were going to Jamalpur at about 09:30 p.m. while they were passing from the Zakir Husain Hostel Pulia, suddenly, the aforementioned student alongwith 10-15 anti-social elements brutally beaten and injured them with butt of Katta (country made pistol). It has further been reported that Osama Aziz alongwith his brother Maaz Aziz and others opened fire at the complainants i.e. Mohd Sadiq & Aatif Afaq with country made pistol (Katta) then the aforementioned students alongwith others runaway from the scene of occurrence.

It is therefore established from the facts mentioned hereinabove that the alleged acts of the above mentioned student amount to misconduct and indiscipline as provided under Part-II, Rule-4 (vii), (xiv) & (xxiii) of AMU Students' Conduct and Discipline Rules, 1985.

On the basis of above misconducts and indiscipline *prima-facie* made out, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry. The University Campus and its maintained institutions are also placed out of bound for him.
