It has been reported vide D. No. 2386/VMH, dated 16.06.2015 by the Provost, Vigarul Mulk Hall that you alongwith your companion named Shaikh Bilal Khalid a student of B.Tech., bearing En.No. GE-1340 entered in the V. M. Hall without any permission of the Provost and Wardens about 2:30 p.m. and broke the sealed lock of Room No. 10 of Jubilee Hostel and picked the Laptop. Mr. Afaq-Un-Nabi Khan (MTS) caught you and brought to the Provost Office for the identification where you didn't show your identity, after that Mr. Afaq handed over you alongwith Laptop to the Security staff for further verification. It is further stated that in Proctor's Office during the course of investigation you in writing admitted your fault.

Taking cognizance of the complaint under reference, a show cause notice vide LD. No. 1781/Proc. dated 18.06.2015 was served, Nabeel Ahmad, aforementioned student whereby he was required to submit his reply within three days from the receipt of the show cause notice. The reply of the aforementioned student was received in this Office vide R.No.3331/Proc. dated 20.06.2015 but in his written submission he could not prove himself absolutely innocent and also admitted the guilt in the reply of show cause, as mentioned in the letter of the Provost, V.M. Hall.

It is therefore established from the facts mentioned hereinabove that the alleged acts of the above mentioned student amount to misconduct and indiscipline as provided under Rule- 4 (ii), (xvi), (xviii) & (xxiii) of AMU Students' Conduct and Discipline Rules, 1985.

On the basis of above misconducts and indiscipline, the aforementioned student is hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry. The University Campus and its maintained institutions are also placed out of bound for him.
