It has been reported & alleged vide No. 78/PS/FE dated 28.07.2015 addressed to the Vice-Chancellor by Dean Faculty of Engineering & Technology, AMU that you being a student of B.E. (Mechanical, III Year) bearing Faculty No. 012MVB-577, En. No. GE-4715 appeared in the admission test of B.E. (Electrical) 2015-16 for which you were not eligible. You qualified admission test of B.E. (Electrical) with a rank of 15 but you did not report for admission for reasons better known to you. It has also been stated that you provided the wrong information about your admission form such as address, date of birth and email address etc. It is also pertinent to mention here that it has been alleged by one of your companion Samiullah that you filled his admission form and also signed on his behalf as if you are Samiullah. And Samiullah also stated that you used to appear in the admission test of B.E. for last several years in the same fashion as you did this year, to benefit other aspirants.

On the basis of the above stated facts and the averment of your companion Samiullah, it is prima-facie established that you appeared in the aforesaid entrance test illegally to assist Samiullah Khan in the entrance test of B.E. Therefore, you committed the acts of gross misconduct, adopted fraudulent means and furnished false information to the University authority.

Taking cognizance of the complaint under reference, a show cause notice vide D. No.2280/Proc. dated 04.08.2015 was served to you whereby you were required to submit your reply within three days from the receipt of the show cause notice. The reply has been received in this Office vide R.No.4378/Proc. dated 06.08.2015 but in your written submission you could not prove yourself innocent and admitted the fact that you appeared in the admission test for the sake of your C.V. upgradation and also admitted that you filled the application form of Samiullah on his request for his help. You also admitted that you entered incorrect Date of Birth and submitted the excuse and also sought pardon.

It is therefore established from the facts mentioned hereinabove that the alleged acts of you amount to misconduct & indiscipline as provided under Part-II Rule- 4 (x), (xi), (xxii), (xxiii) & (xxiv) of AMU Students' Conduct & Discipline Rules, 1985.

On the basis of above misconducts & indiscipline, you are hereby placed under suspension with immediate effect from the rolls of the University pending enquiry, in exercise of the powers delegated by the Vice-Chancellor to the undersigned. The University Campus & its maintained institutions are also placed out of bound for you.
