It has been reported by FIR Lodged D.No.3682/Proc. dated 9.12.2015 at about 04:20 pm that when Mr. Shahzaman Khan (Research Scholar, Department of Political Science) alongwith Mr. Mohd. Zoraiz (Research Scholar, Department of Law) and Javed (another Research Scholar, Department of West Asian Studies) were consuming tea at Library canteen then students namely Naushad of B.A. & Anas Pasha of B.S.W alongwith some notorious criminals namely Sameer of kakrala & javed of Qayam Ganj & some other ruffians publicly abused and physically assaulted Mr. Shahzaman Khan & when he and his companions restrained above noted students and their criminals companions from doing so, then Sameer of Kakrala, the notorious companion of above noted students while acting in prosecuting their common object, physically assaulted and fired fatal gunshot upon Shahzaman Khan with intention of causing his death & it caused severe injury on the vital part of Mr. Khan's body. Above noted students alongwith their companion while acting in furtherance of their common intention created nuisance in the premises of the University by their behavior and criminal acts whereby above noted students and their companions caused public nuisance and disturbed law and order situation in the campus. It is also pertinent to mention here that above noted students alongwith their companions while possessing deadly weapons also threatened Shahzaman and his friends to kill them if they dare recourse to the protection of public authority.

It is therefore prima-facie established from the facts mentioned hereinabove that the alleged acts of aforementioned students amount to gross misconduct & indiscipline as provided under Part-II, Rule-4 (i), (iii), (vii), (xiv), (xxii) & (xxiii) of AMU Students' Conduct & Discipline Rules, 1985.

On the basis of the above misconducts & indiscipline, aforementioned students are hereby placed under suspension with immediate effect from the rolls of the University pending enquiry, in exercise of the powers delegated by the Vice-Chancellor to the Proctor. The University Campus & its maintained institutions are also placed out of bound for the aforementioned students.
