It has been reported and seriously alleged vide complaint R.No. 3083/Proc. dated 03.11.2013, duly signed by 24 resident members of the Dr. B.R. Ambedkar Hall that while bus which had gone to Meerut boarding the students to participate in the funeral of (Late) Mr. Mohd. Sadiq Tomar, a student of BALLB (II) reached near the gate of B.R. Ambedkar Hall some outsiders riding on bikes stopped the bus. As soon as Bus stopped the outsiders barged therein. The aforementioned students thereafter reportedly started instigating MARO, MARO, consequently they started thrashing students of Dr. B.R. Ambedkar Hall but they managed to escape inside the Hall. It has been further reported vide R.No. 3081/Proc.dated 04.11.2013 by one Ashutosh Mishra BALLB IIyear (IIIrd Semester) and resident member of Room No. 31 upper 'A' Block, Dr. B.R.Ambedkar Hall that aforementioned students alongwith their accomplices perused him inside the Hall and attacked him with iron rods and country made pistol (Katta). Consequently he sustained fatal injuries on his face and head. Ashutosh Mishra was taken to the hospital in perfusedly bleeding condition. An FIR lodged by Ashutosh Mishra vide D.No. 3081/Proc. dated 04.11.2013 to this effect was forwarded to the SHO Civil Dodhpur Aligarh for necessary action.

In view of the above facts and circumstances it is prima-facie established that aforenoted students have committed acts of gross misconduct and indiscipline as provided under Part-II, Rule-4 (iii), (iv), (vii), (xiv), (xix), (xxii) and (xxiii) of AMU Students` Conduct and Discipline Rules, 1985.

On the basis of above misconducts and indiscipline *prima-facie* made out, Mohd. Umar Farukh, Gulsher Ahmed, Salman Ahmed and Alamgeer are hereby placed under suspension in exercise of the powers delegated by the Vice-Chancellor to the undersigned with immediate effect from the rolls of the University pending enquiry. The University Campus and its maintained institutions are also placed out of bound for them. The aforementioned students are also required to vacate their rooms immediately.
