4. The firm must be registered supplier in any Government Organisations or in Central Purchase Office, A.M.U. Aligarh.
5. The contract period will be one year from the date of agreement.
6. The firm/company must have working experience (operation maintenance) in 500 or above bedded Hospital.
7. The firm/ company's person should attend the breakdown calls within an hour.
8. Quarterly preventive maintenance services to be done and record of the same shall be submitted to this office soon after completion of the same.
9. Documents required to be attached with CAMC tenders/ quotations as follows:
 - a) Experience Certificate
 - b) Registration Certificate etc.
10. The mode of payment for CAMC is made on half-yearly or quarterly arrear basis.
11. The Mediation Clause of the University is as under:

In case of any dispute between the parties in relation or arising out of this Agreement, prior to invocation of Arbitration Clause, the aggrieved party, shall refer the matter to The Vice Chancellor AMU for pre litigation settlement. The Vice Chancellor, AMU upon such request for mediation shall himself or through his nominee shall mediate between the parties to resolve the issue and shall express his opinion in writing after making effort for settlement after giving both parties an opportunity of being heard. In the event of the mediation fails the mediator shall refer the matter to Arbitration.
