NOTE:

1. All Instruments/Equipments should be manufactured by ISO 9001:2008, ISO 13485:2003 Certified Company.
2. Company should have ISO certified ISO 7153. Certificates should be provided along with the Technical Bid.
3. All surgical instruments/Equipments should be CE European/USFDA certified. Certificate should be necessarily with provided the tender.
4. Surgical Instruments made by steel grade AISI 410 and 420, Test report should be submitted.
5. Certificate of quality from the manufacturer is to be provided with the tender as also with the instruments.
6. Instruments/Equipments should be of International Standard.
7. All Instruments/Equipments should be stoneware coating & long lasting due to high hardness. Light weight anti glaring surface, better vision.
8. All Non consumables articles (except glass or imported articles) like instruments, equipments and others accessories etc should bear "AMU" without which the supply will not be entertained.
9. Demonstration of some of the Instruments/Equipments will be called before purchase.
10. Bidder should submit original literature/Broacher of quoted Model, Technical compliance details.

Terms & Conditions

1. Only the manufacturing Company/authorized dealers/distributors are supposed to apply, preferably the manufacturing Company.
2. Authority letter / Certificate of the manufacturer in case of authorized dealer of the manufacturer (authentic proof) along with tender/quotation is required, otherwise the tender/quotation will not be considered and rejected forthwith.
3. Only typed Tenders/Quotations bearing GST No. on original letter head will be entertained. Quotations must be legible, clear and free from overwriting/erosions. Incomplete quotations are liable to be summarily rejected.
4. The firm must be registered with GeM Portal and in Central Purchase Office, A.M.U., Aligarh./Udyog Aadhaar in case the item is not available on GeM.
5. Rates should be mentioned as per model & make separately. Bidders/Suppliers should quote one rate for specific item.
6. Conditional Tenders/Quotations shall not be accepted.
7. Period of validity of rates of items must be clearly mentioned.
8. GST rate & HSN Code must be clearly mentioned separately against each item, otherwise quotation will not be
