The appointment will be made as Assistant Professor (Contractual) on fixed salary and to be filled as per UGC norms. The appointment will be purely temporary basis liable to termination at any time without any notice or assigning any reason. **The specializations in which positions are to be filled are as follows:**

1. Physics: 01
2. Biotechnology: 01

Essential Qualifications:

Eligibility (A or B)

(A)

- I. Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level, in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university **with research experience in the areas of Nanomaterials/Nanotechnology.**
- II. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by UGC like SLET/SET.
- III. Notwithstanding anything contained in sub-clauses (i) and (ii) above, Candidates, who are or have been awarded a Ph.D. Degree in **Nanotechnology related areas** accordance with the University Grant Commission (Minimum Standards and Procedure for award of Ph.D. Degree Regulations, 2009) shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET.
- IV. NET/SLET/SET shall also not be required for such Masters programmes in disciplines for which NET/SLET/SET is not conducted.

Further, the award of degree to candidates registered for the M.Phil/Ph.D. programme prior to 11 July 2009, shall be governed by the provisions of the then existing Ordinances/By laws/Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor of equivalent positions in Universities/Colleges/Institutes subject to the fulfilment of the following conditions:-

- a. Ph.D. degree of the candidate awarded in regular mode only;
- b. Evaluation of the Ph.D. thesis by at least two external examiners;
- c. Open Ph.D. viva voce of the candidate had been conducted;
- d. Candidate has published two research papers from/based on his/her Ph.D. work out of which at least one must be in a refereed journal;
- e. Candidate has made at least two presentations in conferences/ seminars, based on his/her Ph.D. work.

(a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor /Dean (Academic Affairs)/Dean (University Instruction).



The Ph.D degree has been obtained from a foreign University/Institute with a ranking among top 500 in the world University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) The Academic Ranking of World University (ARWU) of the Shanghai Jiao Tong University (Shanghai).
