

TERMS & CONDITIONS

1. Goods are required to be dispatched F.O.R. i.e. Department of Forensic Medicine, A.M.U., Aligarh in the name of the Chairman, Department of Forensic Medicine, Aligarh Muslim University, Aligarh
2. The Department has the right to accept the rates of some or all the articles required. The Department reserves the right to reject any or all the quotations without assigning any reason or to allot full or part of the supply to one or more Firms.
3. Payment shall be made against bill.
4. The goods have to be supplied within 08 days otherwise the order shall be treated as cancelled. For goods supplied after the stipulated period must be supported with regular sanction of extension of the period by the competent authority.
5. In case goods are not according to specifications, the cost of returning them shall be borne by the supplier.
6. The rate should be kept open/valid for periods of three months from the date of quotations were opened.
7. The quotations containing uncalled for remarks are liable for rejection.
8. The firm registered with Sales Tax Authority should mention GSTIN.
9. The discount rebate admissible if any, may be quoted.
