- 10 inch × 1.5 inch wooden top (Neem/Aam) × 11 ft. 11 inch long (03 tops are required in each bench/table)
- 07 inch × 1.5 inch wooden back support (Neem/Aam) × 11 ft. 11 inch long

2. **Table for Lecture Theatre**


- 1.5 inch × 1 inch iron pipe framed structure, covered with ply wood  
02 drawers and two cupboards should be at both ends of the table.
