


S. No	Terms	Remarks
1.	Payment Terms	Quarterly/ Half Yearly in arrears and the tax applicable at the time of Invoicing. The billing address should be same as mentioned in the agreement and also attach the copy of PAN Card and Bank details at the time of Invoicing.
2.	Preventive Maintenance	The firm will provide Three Preventive Maintenance Service in a year (except break down calls). The report of the maintenance service should be submitted to the In-charge of the concerned unit/ section.
3.	Break Down Calls	Unlimited and the firm will attend the complaint within 24 hours except holidays.
4.	Contract Period	One year from the date of Agreement. However, if the service of the service provider is not found satisfactory, the client reserves its right to terminate this agreement by giving one month advance notice.
5.	Parts Included in CAMC	The following parts are included in CAMC:
6.	Parts Excluded from CAMC	The following parts are excluded from CAMC:
7.	Defective Parts	The firm will deposit the defective/ replaced part to the concerned person of that place.
8.	Damage/ Mishandling of Equipment	The firm will not responsible for damage of the equipment such as broken part, mishandling the system, accidental damage, damage due to high voltage or fluctuation in voltage etc. It is not cover under CAMC.
