**QUALIFICATION:**

**Essential:**

- (i) Good academic record as defined by the concerned university with at least 55% marks (on an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in the relevant subject from an Indian University Or an equivalent degree from an accredited foreign University.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- (iii) Not with standing anything contained in sub-clauses (i) and (ii) candidates, who are or have been awarded a Ph.D. Degree in accordance with the University Grants commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulation, 2009 or the subsequent Regulations if notified by the UGC, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.
- (iv) NET/SLET/SET shall also not be required for such Master Programmes in Disciplines for which NET/SLET/SET is not conducted.

Further, the award of degrees to candidates registered for the M.Phil/Ph.D programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/By laws/Regulations of the Institution awarding the degrees and the Ph.D. candidates shall be exempted from the requirement of the minimum eligibility conditions of NET/SLET/SET for the appointment of Assistant Professor or equivalent positions in the University/Colleges/Institutions subject to fulfillment of the conditions:

- a) Ph.D. degree of the candidate awarded in regular mode only;
  - b) Evaluation of the Ph.D. thesis by at least two external examiners;
  - c) Candidate had published two research papers out of which at least one in a refereed journal from out of his/her Ph.D. work;
  - d) The candidate had presented two papers in seminars/conferences from out of his/Ph.D. work;
  - e) Open Ph.D. Viva-Voce of the candidate had been conducted.
- (a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean (Academic Affairs)/Dean (University Instructions).
- (v) A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. degree holders who have passed their Master's degree prior to 1991.
  - (vi) A relaxation of 5% may be provided from 55% to 50% of the marks to the Master's/Graduate level for the SC/ST/physically and visually handicapped candidates.
  - (vii) Relevant grade which is regarded as equivalent of 55% where the grading system is followed by recognized University shall also be considered eligible.
