

TERMS & CONDITIONS

1. Interested parties can participate the auction after depositing the Demand Draft of Rs.10000.00 as security amount (refundable) in favour of the Finance Officer, AMU, Aligarh before the auction.
2. Interested parties can see the condemned items from in the Faculty of Arts, AMU, Aligarh during office hours.
3. The lots for which offers not found suitable will be put to auction amongst eligible bidders only starting from the highest offers already received and thereafter highest bid so received will be subject to final acceptance or rejection of the Auction Committee on the spot.
4. Highest offer found suitable will be declared accepted in the auction.
5. Successful bidder will have to deposit 25% of the offered amount in cash immediately after finalizing the bid failing which the security amount Rs.5000/- will be forfeited in favour of the AMU, Aligarh.

6. In case the bidder did not turn up within 10 days from the date of finalizing the bid to take the delivery, and amount 2% of the auction value per day shall be charged as ground rent for next 15 days and thereafter the deposited amount shall be forfeited in favour of the AMU, Aligarh.
7. The Auction Committee reserves the right to accept or reject any or all offers/rescheduled or postpone the auction without assigning any reason, to allow entry and participation in the auction and mode of disposal.
8. All the cases of dispute will be subject to Aligarh District Court Jurisdiction.
9. Other terms and conditions shall be announced at the time of the auction.
