

### INVITATION FOR QUOTATION

#### Sub: Invitation for Quotations for supply of EPABX

1. You are invited to submit quotation for the following EPABX specifications as given below:

#### 2. Quotation:

2.1 The contract shall be for the full quantity as described above.

2.2 All duties and other levies payable by the supplier under the contract shall be included in the unit price.

2.3 Applicable taxes shall be quoted separately.

2.4 The prices quoted by the firm shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

2.5 The Prices should be quoted in Indian Rupees only.

2.6 The Sealed quotation/Tender shall reach the office of the undersigned in sealed cover by **16<sup>th</sup> June 2016** upto 12.00 Noon.

3. Each firm shall submit only one quotation.

4. Quotation shall be valid for a period of at least **90** days after the last date of quotation submission.

5. **Warranty:** A certificate of the original equipment manufacturer of the offered exchange shall be provided. The complete system shall be guaranteed against any manufacturing defect and mal functioning for the duration of the warranty period from the date of handing over the system to the University after commissioning. During this period the system is to be maintained free of cost.

6. **AMC:** The firm shall submit a certificate of providing Annual Maintenance Contract for at least 10 years after the expiry of the warranty period.
7. **Maintenance Spare:** The guarantee to the effect that all the spare parts shall be available for its maintenance for a minimum 10 years beyond commissioning shall be enclosed.
8. **Payment Terms:** 100% after the system has been installed and successfully commissioned duly accepted and certified by the MIC (Telephones) AMU Aligarh.
9. The Purchaser reserves the right to accept or reject any quotations and reject all quotations at any time prior to the award of contract.
10. Information brochures/ Product catalogue, if any must be accompanied with the quotation clearly indicating the model quoted for.
11. The firm must have valid Sales tax/Tin Number.
12. Documentary evidence of supplying the EPABX to the Government Agencies/Universities must be enclosed.
13. The firm must be registered to supply with Aligarh Muslim University or DGS&D any Central Government Organization. Please enclosed a copy of the certificate.

## **Termination**

### **1. Termination of Default**

AMU may, without prejudice for breach of contract; ten days after written notice of default sent to supplier, terminate this contract in whole or in part

- a) If he fails to deliver full or part consignment within the time period specified in the contract, or any extension thereof granted by AMU.
- b) If he fails to perform any other obligations under the contractor.
- c) If he, in either of the above circumstances, does not cure his failure within a period of 30 days or longer period as specified by AMU after receipt of the default notice from AMU.

In the event AMU terminates the contract in whole or in part, pursuant to above, AMU may procure, upon such terms and in such manner, as it deemed appropriate, equipment/plant similar to those undelivered and supplier shall be liable to indemnify AMU for any costs for such similar equipment/plant.

### **2. Termination for Insolvency**

AMU at any time terminate the contract by giving written notice to supplier without any compensation, if the supplier becomes bankrupt or otherwise insolvent or unsuccessful to commission this work, provided that such termination will not prejudice or effect any right to action or remedy which has accrued thereafter to AMU.

## **Arbitration/Settlement of Disputes**

1. All dispute subject to Aligarh Jurisdiction or as per University rules.
2. The contract shall in all respect be construed and operative in conformity with the Indian Law and be subject to the jurisdiction of Aligarh Court (India) only.
