The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
  - 8.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
  - 8.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.

1	3D Scanner	<b>Orion 3D smart scanner</b> -The instrument must be 3D White Light based Scanning hardware (portable type). It should be suitable to measure and scan the objects at normal room temperature. System should have capability of 3D scanning & active sync or alignment of scan shorts by using targets or rotary table. System should be based on minimum 2 camera technology with projector and camera should be separate identity. Resolution of cameras should not be less than 1.3 mega pixels and should have provision to upgrade at higher resolution in future. Scanner should be capable to cover job from 50mm to 1000mm length minimum. Accuracy of scanner system should be from 0.1mm to 0.2mm.
