Applications on prescribed form are invited for the appointment of Guest Faculty in the Department of Plant Protection, Faculty of Agricultural Sciences on payment of fixed emoluments not less than the monthly gross salary of a regular appointed Assistant Professor **for the session 2014-15**. The appointment will be made on purely temporary basis liable to termination at any time without notice or assigning reason.

Qualifications:

- i. Good Academic record as defined by the concerned University with atleast 55% marks (or an equivalent grade in a pay scale wherever grading system is followed) at the Master's Degree level in Plant Protection with specialization in Plant Pathology and Nematology, or M.Sc degree with specialization in Plant Pathology or Nematology or both from an Indian University, or an equivalent degree from an accredited foreign University.
- ii. Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR, ICAR etc.
- iii. Notwithstanding anything contained in sub-clause (i) and (ii) above candidates, who are or have been awarded a Ph.D Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulations, 2009 shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor of equivalent position in Universities/ Colleges/ Institution;

Note:

- (i) A relaxation of 5% may be provided at the graduate and Master's level for the Scheduled Caste/ Scheduled Tribe/ Differently-abled (Physically and visually differently-abled) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions. The eligibility of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace marks procedures.
- (ii) A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. Degree holder, who have obtained their Master's degree prior to 19 September, 1991.

Candidates will not be paid TA/DA to attend the interview.
