Applications on prescribed form are invited for the appointment against the **Guest Faculty in Computer Applications and Theory** Department of Commerce on payment of an honorarium as per University Rules. The appointment will be purely temporary till the end of the academic session **2014-2015**, and liable to termination at any time without any notice or assignment of reason thereof.

**Essential Qualifications:**

- i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar fest accredited by the UGC like SLET/SET.
- iii. Notwithstanding anything contained in (i) and (ii) above, candidates who are, or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Guest Faculty.
- iv. NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.


Prescribed applications forms may be downloaded from the University's Website "[www.amuregistrar.com](http://www.amuregistrar.com)" and submit the same in the office of the Chairman, Department of Commerce AMU during office hours along with a cash Receipt of Rs. 150/- to be deposited in State Bank of India, Branch AMU, Aligarh.

Last date for submission of application forms is **18.06.2014**. Working and retired employees are not eligible to apply. Candidates called for interview will not be paid TA/DA.
