Applications are invited on the prescribed form for **one post of Assistant Professor in Economics (Law)** in AMU Malappuram (Kerala) Centre in the pay scale of Rs. 15600-39100 plus allowances as admissible under University rules. The appointment will be purely temporary till the end of academic session 2013-14 and liable to termination at any time without any notice or assignment of reason:

**Essential Qualifications:**

- (i) Good academic record as defined by the concerned University with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's level in relevant subject from an Indian University or an equivalent degree from an accredited foreign University;
- (ii) Relaxation of 5% may be provided from 55% to 50% of the marks to the Ph. D. degree holders, who have obtained their master's degree prior to 19<sup>th</sup> September, 1991.
- (iii) Besides fulfilling the above qualification, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC/CSIR or similar test accredited by the UGC like SLET/SET FOR those with Ph.D. degree. However, the candidates having Ph.D. in the concerned subjects are exempted from NET.
- (iv) Notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates, who are or have been awarded a Ph.D. degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. degree) Regulations, 2009 shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor/Guest Faculty.
- (v) NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted.

Applications duly filled in should be submitted in the Office of the undersigned **on or before 31.12.2013** during office hours along with Demand Draft/Original Cash receipt of Rs. 150/-. Incomplete applications or those received late shall not be considered. Candidates to be called for interview will not be paid T.A./D.A. **The Interview for the above mentioned post will be held on 11.01.2014 (Saturday) at 11: 00 a.m. in the chamber of Dean, Faculty of Law, A.M.U., Aligarh.**
