Essential Qualifications:

(i) Good academic record with at least 55% of marks (or an equivalent grade of B in the 7 point scale wherever grading system is followed) with latter grades O, A, B, C, D, E & F at the Master's level, in the relevant subject from an Indian University or an equivalent degree from a foreign University.

(ii) Relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. degree holders, who have obtained their master's degree prior to 19th September, 1991.

(iii) Besides fulfilling the above qualification, candidates should have cleared the National Eligibility Test (NET) for Lecturers conducted by the UGC/CSIR or similar test accredited by the UGC. However, candidates having Ph.D. in the concerned subjects are exempted from NET.

(iv) notwithstanding anything contained in sub-clauses (i) and (ii) above, candidates who are or have been awarded Ph.D. degree in accordance with the U.G.C. (Minimum standards and procedure for award of Ph.D. degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SELT/SET for recruitment of Assistant Professor/Guest Faculty.

Or

The candidates having been awarded Ph.D. degree prior to 11.07.2009, the date of notification of UGC (Minimum Standard and Procedure for award of Ph.D. degree) Regulations 2009, or admitted prior to the aforesaid date and awarded Ph.D. after the above notification shall also be eligible to apply for the post of Assistant Professor/Guest Faculty provided they fulfill minimum 6 out of 11 criteria recommended by the Thyagrajan Committee and produce a certificate to this effect issued by the office of the Controller of Examinations, AMU.

Prescribed application form may be downloaded from the University's official website "www.Amuregistrar.com" and submit the same in the office of the undersigned during office hours along with a cash receipt of Rs.150/- in original, to be deposited in the State Bank of India (AMU Branch).

Applications complete in all respect should reach in the office of the Chairman, Department of Law, A.M.U., Aligarh **by 05.10.2013**. Working and retired employees are not eligible to apply. Candidates to be called for interview will not be entitled to payment of T.A./D.A. Incomplete applications or those received late shall not be considered.
