They will be governed by the terms and conditions of the services of Non-Teaching employees as laid down in the Chapter XL of the Ordinances (Executive) and also be governed by the newly Defined Contribution Pension Scheme as adopted and implemented by the University vide Office Memo No. (c)/148 dated 08.02.2005.

Under the University rules, they are required to produce the Physical Fitness Certificate from the Medical Officer of the University or any Medical Officer authorized for the purpose.

Under the general directives of the Executive Council, they are also required to join their duties within four months from the date of issue of this Office Memo, failing which, the offer of appointment will be cancelled.

In terms of the standing orders of the Vice-Chancellor as communicated vide Office Memo No. D.1061/PF dated 08.03.2014, they are directed to fill up the application form for registration of Permanent Retirement Account Number (PRAN) at the time of joining. No joining report will be entertained without duly filled application form of PRAN. The Principal & CMS, JNMC is requested to ensure compliance and send joining report of the employees concerned with duly filled application form of PRAN to AFO (Salary).
