SCHOLARSHIP AND REIMBURSEMENT FEE ONLY SYSTEM**", for the session **2019-2020**. The Scholarship Schemes are online Schemes. Terms and Conditions:-

As per the prescribed terms and condition of this scholarship-

1. A student holding this scholarship will not avail any other scholarship/stipend for pursuing the course.
2. The student belonging to U.P. State and whose parents' annual income from all sources does not exceed Rs.2 lakh p.a. (in case of OBC minority and General) and category SC/ST must not exceed more than 2.50 Lakh p.a.
3. Scholarship will not be given to more than two students from a family (applicable for all Scholarship schemes).
4. Migration of students from one school/institute to another is not allowed for renewal applicants during the period of academic course.
5. Students applied for Central Government scholarship in the session 2019-2020 are not eligible to apply in the above scholarship.

Application form complete in all respect, alongwith the following documents duly countersigned by the concerned Provost/Dean should be submitted in DSW office latest by **26.08.2019**.

1. Latest Income certificate of Parents/Guardians issued from Tehsildar / SDM / MP / MLA/MLC/ Chairman, Nagar Palika/Mukhya Nagar Adhikari/Gazetted Officer of the home district.
2. Residential Proof issued from Tehsildar/SDM of home district only.

(Note:- Certificate from other than the above officers shall not be acceptable. Student may get this certificate in his/her own or his father's name through fax/E-mail etc from home towns)

3. Attested photocopies of Admission Card/Identity Card & All Marksheets Demand slip/Dues slip for one year of the current course to be issued to the students from the Provost of the concerned hall/NRSC.
4. Applicant must provide his/her own bank account number and not in the name of his/her parents, guardian. Those do not have a bank account number may open a bank account in any bank of Aligarh.

Incomplete applications in any manner would be rejected.

IMPORTANT INSTRUCTIONS:-

1. Check your application form status within 10 or 15 days after submitting form, if found any problem please contact immediatly to DSW office.
2. Bank Account holders must check their 'Know your Customer' (KYC) status from bank and if required the KYC must be done for successful transaction of scholarship amount
3. Bank Account must be operational/active till the scholarship is disbursed. Ministry of Minority Affairs will not be responsible in case of transaction failure in the account given by applicant.
4. Bank Account must be preferably in any scheduled Bank with core banking facility and proper IFS Code
5. Bank Account must be in the name of the student
